Thank you for the submittal of the Draft Fact Sheet for public notification, dated March 31, 2014, of the draft Corrective Action Plan (CAP) prepared by Antea Group on your behalf. Alameda County Environmental Health (ACEH) has reviewed the draft Fact Sheet and has provided a final Fact Sheet and distribution list for mailing to property owners and tenants in the vicinity of the site as attachments to this Directive letter.
