Just wanted everyone to know that I finally got in touch with Mr. Usman today (after numerous attempts). I had explained in previous conversations with him that I needed to know an answer today as to whether he was going to sign the access agreement amendment so that the monitoring and scheduling event could move forward at the end of the month. Mr. Usman is

REFUSING to sign any agreement until he speaks with the regulator. Mr. Usman indicated that he has now left two messages for the regulator and has not received a call back.

I also explained that I will be resending him new agreements at the beginning of the month (I believe this next round will be the 3rd request I have sent to him) and will be following up with him once I have sent those agreements out. Finally, I mentioned that by not signing, he is only delaying having the samples taken and having new information to send to the regulator...ultimately just dragging this whole process out longer. That fact didn't seem to make a difference.

Shelby and Brad - if there is anything that either one of you can do to either put Mr. Usman in touch with the regulator or visit him personally to obtain his signature on the amendment to access agreement, it would be greatly appreciated. I truly believe though, that despite all of the information that has been provided to him thus far, we will not sign until he has that conversation with the regulator. Hopefully then, he will hear from the county what we have been trying to explain to him for months.
