MEMO to file:

I spoke today with Glen VanderVeen (IT Grp) regarding the 22 Sept 1999 response to my request for revisions to the original July 2, 1997 EMCON work plan for the assessment of the sanitary sewer trenches. The 9/89 response proposed a "risk based" approach, an additional change to even the 1st subsequent proposal dated 9 Feb 1999, which proposed collection of vapor samples from within the sewer line itself as an alternative to collecting C6 from the trenches.

It appears that the crux concern^{of the} is the notion of pushing a power-tool (i.e., GeoProbe) into a buried utility trench. Potential damage to the sewer pipe and consequent liability weighs heavily on their minds.

I suggested hand augering in lieu of using a GeoProbe. Mr. VanderVeen was amenable to this. He will go back through all the previous notes, memos and the 1997 w.p. and see how he can revise and revise the original project goals and concepts.

MEMO to file:

I spoke today with Glen Vander Veen (I.T. Corp) re: the 2/2/89 Pinnacle revised utility trench work plan. This revision is substantially modified from the original 7/87 work plan. First, the revised plan no longer proposes soil borings w/ GW samples but, rather, the collection of vapor samples from within the sewer line. Second, it proposes to focus its effort on the storm sewer. The sanitary sewer in the center of Leuwelling Blvd. (and a lateral along the south of the site) is where this work should focus.

I advised Mr. Vander Veen that the original work plan is more appropriate to the goal of determining whether or not sewer trenches may act as conduits for plume migration. I will FAX an excerpt of a map to him that shows the location of the aforementioned sewer lateral. I also gave him the names of a driller and utility locator service (Gregg Drilling, C.U. Surveys) that were recently used for similar work at an Oakland site.
