Hello Barbara,

As we discussed on March 18, 2009, United Parcel Service (UPS) has scheduled the removal of three diesel underground storage tanks (USTs) at the UPS Oakland Hub. The UST removal activities are scheduled to begin next Monday, March 30<sup>th</sup>, and are anticipated to continue into the following week. Along with removing the USTs and the associated piping and dispensers, UPS plans to aggressively remediate impacts to the subsurface by over-excavation and pumping out free product, if encountered, and water from the tank pit.

In ACEH correspondence dated March 10, 2009, you requested UPS to submit a site conceptual model (SCM) to the ACEH by April 27, 2009. On behalf of UPS, ARCADIS requests that the SCM requirement be withdrawn at this time, based on UPS' plans for remediation during the UST removal activities. Once the results of the UST removal have been submitted to the ACEH, discussion of any additional requirements at this site in order to obtain closure will be initiated.

If you would like to be onsite during any of the tank removal activities (i.e. during confirmation sampling), please let us know and we will communicate with you regarding the expected dates of specific activities. We can subsequently notify you when the dates are finalized.

Please advise if the ACEH has any specific requirements for UST closure and/or other protocols that you would like followed.
