Good Morning Keith,

Hope you are having a lovely spring. Have you had a chance to review our request to complete our investigation at Oakland? In our most recent report we requested finishing the investigation that began in 2015.

Arcadis will complete the additional subsurface investigation east of borings FPB-16 and FPB-17 (MW-26 and MW-27), north of borings FPB-18 and FPB-19 (MW-28 and MW-29), and south of boring FPB-8 (MW-19). These borings will be advanced to complete the tasks outlined in the Expanded Work Plan for Free Product Delineation (Arcadis 2015a) and the Field Investigation and Second Semiannual Groundwater Monitoring Report (Arcadis 2015b). Arcadis' objective is to delineate free product, while monitoring the soil gas methane conditions, prior to recommending the necessary remedial actions to mitigate free product to the maximum extent practicable.

Once we complete this field event we can develop a plan moving forward.
