Dear Mr. Detterman:

This letter report presents an update on the Former Paco Pumps facility located at 9201 San Leandro in Oakland, California, Case No. R0000320 for the second quarter of 2012.

On May 10, 2012, Alameda County Health Care Services (County) requested revisions to the January 13, 2012 Sub-Slab Survey and Remedial Investigation Workplan (RI Workplan) prepared by The Source Group, Inc (SGI). On May 23, 2012, the First Quarter 2012 Groundwater Monitoring Report was submitted to the County. On June 20, 2012, SGI submitted revisions to the RI Workplan. The revisions were based on the County recommendations and on recent modifications to buildings at the site.

No groundwater monitoring was conducted this quarter. The RI Workplan revisions submitted in June 2012 included the proposed installation of two groundwater monitoring wells. As the proposed wells have not yet been approved or drilled, and as the proposed groundwater sampling for Monitored Natural Attenuation (MNA) parameters proposed for 2012 in the RI Workplan should include the proposed new wells, no groundwater monitoring was conducted during Q2 2012. Semi-annual groundwater monitoring of the site wells is scheduled for September 2012 (regardless of the installation of the proposed additional wells), and MNA sampling will be scheduled after the installation of the two proposed additional wells.

Pending approval from the County of the Workplan revisions, the third quarter activities will include sub-slab soil gas sampling and evaluation of vapor intrusions concerns, installation and sampling of two monitoring wells, and reporting with additional recommendations.

Pending the County's approval of the revised RI Workplan, no groundwater monitoring event was conducted during Q2 2012. If approved by the County, the third quarter activities will include sub-slab soil gas sampling and evaluation of vapor intrusions concerns, installation and sampling of two monitoring wells, and reporting with additional recommendations.

Semi-annual groundwater monitoring of the site wells is scheduled for September 2012, and MNA sampling will be scheduled after the installation of the two proposed additional groundwater monitoring wells.
