This document was prepared in response to a complaint received by the neighboring facilities and an investigation made by the City of Hayward Fire Department along with this agency. As you are aware the complaint was due to the odor generated by bioremediation activities using Mushroom Compost along with bay mud. Per this document Decon will take all necessary steps in order to minimize any further odor release by monitoring for hydrogen sulfide, wind speed and direction as well as working after 6:00 PM during the week and on weekends. However, all activities will be ceased if the above measures will not result in satisfactory containment of odor problem in the surrounding properties.

Therefore, I concur with Decon's modification of the remediation activities as set forth within the above referenced document.

This workplan was submitted to this office, due to earlier discussion on the possibility of pursuing active remediation including bioremediation to further pursue clean up of the contaminated soil at the above referenced site.

I understand that you will be using composting-style process to remediate this soil. As you are aware I had verbally approved this process in the past. However, I have read the report, discussed this process with my colleagues, and found it to be an acceptable approach to remediate the contaminated soil at the site. Furthermore, I understand that groundwater will be tested and disposed of to POTW under City of Hayward POTW guidelines.

I observed the over-excavation activity at the above site. Additionally you indicated that you are committed to continue work without interruptions in order to complete the clean up project at the above referenced site.

I have also received a faxed document dated September 12, 2001 by Mr. Lowe regarding "Addendum I to January 06, 2000 Workplan for Excavation" regarding the above referenced site.

Per our discussion today, the over-excavation and placement of three monitoring wells will be based on the flow gradient and most contaminated area at the site per illustration in figure 1 of this addendum. However, I understand that an additional workplan will be submitted to this office prior to completion of present excavation and to reveal where the three proposed monitoring wells will be located.

Please be advised that pending the groundwater and soil samples laboratory analysis, more investigation might be required to further delineate the soil/groundwater contamination.

- Please ensure that MTBE analysis is performed.
- Pending the groundwater and soil samples laboratory analysis, more investigation might be required to further delineate the soil/groundwater contamination. This includes, but not limited to, the installment of monitoring wells, etc.
- I have discussed in length the idea of treating the excavated soil "on site" rather than having it hauled off-site. I believe your consultant agrees that having the contaminated hauled off-site is a more reasonable approach to this issue. This is due to problem facing possibility of runoff, the need for other legal requirements such as aeration etc, and the proximity to the bay.

- A representative of this office may be present during some of the soil and groundwater sampling events. Please inform this office several days prior to the actual sampling events.
- MTBE analysis must also be performed among the other considered constituents.



#### LANDOWNER NOTIFICATION AND PARTICIPATION REQUIREMENTS

Dear Mr. philips:

This letter is to inform you of new legislative requirements pertaining to cleanup and closure of sites where an unauthorized release of hazardous substance, including petroleum, has occurred from an underground storage tank (UST). Section 25297.15(a) of Ch. 6.7 of the Health & Safety Code requires the primary or active responsible party to notify all current record owners of fee title to the site of: 1) a site cleanup proposal, 2) a site closure proposal, 3) a local agency intention to make a determination that no further action is required, and 4) a local agency intention to issue a closure letter. Section 25297.15(b) requires the local agency to take all reasonable steps to accommodate responsible landowners' participation in the cleanup or site closure process and to consider their input and recommendations.

For purposes of implementing these sections, you have been identified as the primary or active responsible party. Please provide to this agency, within twenty (20) calendar days of receipt of this notice, a complete mailing list of all current record owners of fee title to the site. You may use the enclosed "list of landowners" form (sample letter 2) as a template to comply with this requirement. If the list of current record owners of fee title to the site changes, you must notify the local agency of the change within 20 calendar days from when you are notified of the change.

If you are the sole landowner, please indicate that on the landowner list form. The following notice requirements do not apply to responsible parties who are the sole landowner for the site.

In accordance with Section 25297.15(a) of Ch. 6.7 of the Health & Safety Code, you must certify to the local agency that all current record owners of fee title to the site have been informed of the proposed action before the local agency may do any of the following:

- 1) consider a cleanup proposal (corrective action plan)
- 2) consider a site closure proposal
- 3) make a determination that no further action is required
- 4) issue a closure letter

You may use the enclosed "notice of proposed action" form (sample letter 3) as a template to comply with this requirement. Before approving a cleanup proposal or site closure proposal, determining that no further action is required, or issuing a closure letter, the local agency will take all reasonable steps necessary to accommodate responsible landowner participation in the cleanup and site closure process and will consider all input and recommendations from any responsible landowner.

#### LANDOWNER NOTIFICATION AND PARTICIPATION REQUIREMENTS

Dear Mr. Katwan:

This letter is to inform you of new legislative requirements pertaining to cleanup and closure of sites where an unauthorized release of hazardous substance, including petroleum, has occurred from an underground storage tank (UST). Section 25297.15(a) of Ch. 6.7 of the Health & Safety Code requires the primary or active responsible party to notify all current record owners of fee title to the site of: 1) a site cleanup proposal, 2) a site closure proposal, 3) a local agency intention to make a determination that no further action is required, and 4) a local agency intention to issue a closure letter. Section 25297.15(b) requires the local agency to take all reasonable steps to accommodate responsible landowners' participation in the cleanup or site closure process and to consider their input and recommendations.

For purposes of implementing these sections, you have been identified as the primary or active responsible party. Please provide to this agency, within twenty (20) calendar days of receipt of this notice, a complete mailing list of all current record owners of fee title to the site. You may use the enclosed "list of landowners" form (sample letter 2) as a template to comply with this requirement. If the list of current record owners of fee title to the site changes, you must notify the local agency of the change within 20 calendar days from when you are notified of the change.

If you are the sole landowner, please indicate that on the landowner list form. The following notice requirements do not apply to responsible parties who are the sole landowner for the site.

In accordance with Section 25297.15(a) of Ch. 6.7 of the Health & Safety Code, you must certify to the local agency that all current record owners of fee title to the site have been informed of the proposed action before the local agency may do any of the following:

- 1) consider a cleanup proposal (corrective action plan)
- 2) consider a site closure proposal
- 3) make a determination that no further action is required
- 4) issue a closure letter

You may use the enclosed "notice of proposed action" form (sample letter 3) as a template to comply with this requirement. Before approving a cleanup proposal or site closure proposal, determining that no further action is required, or issuing a closure letter, the local agency will take all reasonable steps necessary to accommodate responsible landowner participation in the cleanup and site closure process and will consider all input and recommendations from any responsible landowner.
