Wanted to give you an update on the San Leandro sites and well destruction plans.

RO366 is scheduled for Feb 4/5 for offsite locations MW-10 and MW-11. We will be hot patching MW-6 to the city's requirements as well.

RO499 has not been scheduled at this time. PG&E has been unresponsive to our requests for a representative to be present during the well destruction. As we discussed the active gas line is within 2 feet of the well casing. Chevron and ARCADIS are going to have an internal meeting to discuss additional options. The well is to be pressure grouted as means of destruction but the city requires the top 3 feet around the well vault to be air knifed, removed, and backfilled with cement.

Based on the challenges above we will need to extend our deadline out again. Can we shoot for the end of March 2015 as the latest?

As we discussed on the phone the two referenced sites have had a few changes with well destructions. Below are the challenges and extension requests.

RO366 – 15008 east 14th Street, San Leandro. MW-10 and MW-11 are located in the public right of way. The various encroachment entities (Caltrans and City of San Leandro) were not accepting of encroachment permits claiming the other entity was responsible. IT took a couple months but Caltrans has approved our encroachment permits to proceed.

These wells will be destroyed in January 2015. We request an extension of this report until January 30, 2015 to accommodate the delay.

RO499 – 500 Bancroft Street, San Leandro. MW-9 is located within 1 foot of an active PGE gas line. PGE has been unresponsive and missed field visit for supervision of hand clearing the area around the well to 3 feet bgs to meet agency requirements. We are still waiting for a call regarding scheduling. I am not confident this will happen in January and would like to request the extension of this report to February 28, 2015.

If additional challenges arise with PGE we will update ACEH.
