Dear Mr. Hwang:

On behalf of Dr. Brian Sheaff, Golden Gate Tank Removal, Inc. (GGTR) requests the Alameda County Health Care Services Agency (ACHCSA), to hereby grant an extension for submittal of the report for additional site characterization activities proposed at Sheaff's Garage located at 5930 College Avenue in Oakland, California. The report was requested by the ACHCSA pursuant to their Technical Report Request presented in their most recent directive letter dated February 22, 2005, and was due in conjunction with the First Quarter 2005 Groundwater Monitoring Report on April 30, 2005. GGTR requests that the ACHCSA grant a 55-day extension from the date of this letter for submittal of the requested report (July 31, 2005), which will be included with the Second Quarter 2005 Groundwater Monitor Report. The request is based on additional time required to complete the site and source characterization field and analysis activities proposed in the public right of way along College Avenue. Interior soil boring activities, including installation and sampling of PW-1, were completed on May 19, 2005. **GGTR is tentatively scheduled to perform the additional boring activities (B21-B23 & HB3-HB8) on June 22, 2005.** Included is a site plan showing the proposed boring locations.

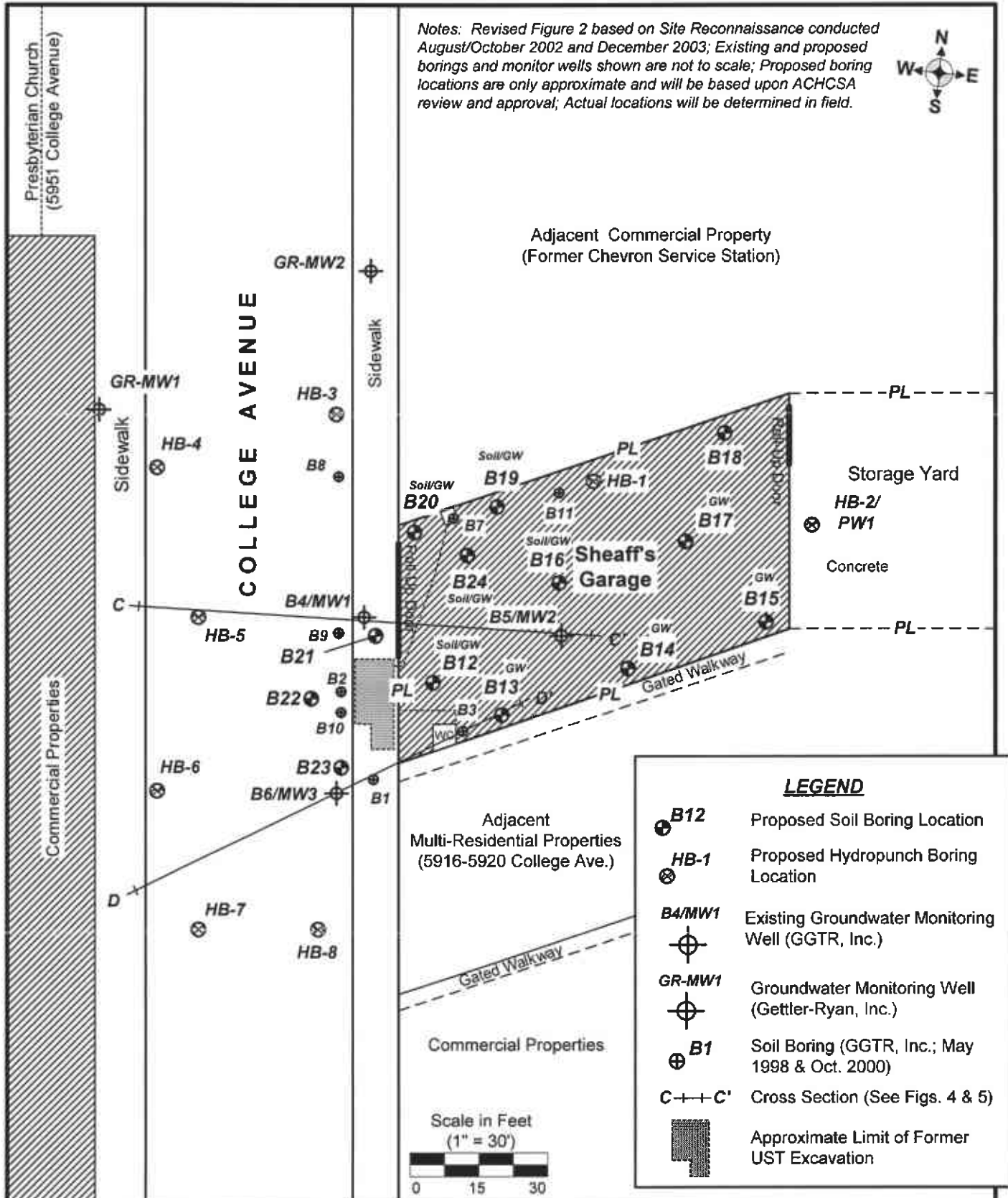
