Thanks for the info. As we discussed yesterday, it seems appropriate to move forward with well destruction, but with one last round of groundwater monitoring at the well to verify no significant changes (using the standard analytical suite for the site). Please coordinate permitting with the ACPWA and provide a short letter report on the specific destruction procedures, copy of the permit, lab data (which get incorporated into the GWM tables so it's not lost in the future), and etc. You can use this email as ACEH acknowledgement (and approval) of your request. If you have questions, do let me know.
