II. SITE DESCRIPTION

This plan specifically refers to one underground storage tank located at the site of Jiffy Lube Store #606, at 2492 Castro Valley Blvd., Castro Valley, CA.

There is one 2,000 gallon tank at this facility (see Section VII, Exhibit A) which contains used motor oil. It is a double-walled steel tank with seel piping.

III. MONITORING PROCEDURES

The tank is continuously monitoring using an ILS-350 Veeder Root monitor located in the annular space of the tank. The sensor detects the presence of fluid between the inner and outer walls of the tank with a detection limit of 1 inch of fluid. The sensor is hooked to an alarm box located in the store and which has both audible and visual alarms.

V. SPILL RESPONSE PROCEDURES

In the event of a release of large amounts of used oil from the tank or overfill, the on-site coordinator will evacuate the immediate area. The on-site coordinator will make the determination as to what necessitates a complete evacuation of the property based upon the threat of human health and safety and notification of evacuation will be given by the on-site coordinator. The evacuation staging area for this store is located on thesidewalk at the south end of the property, adjacent to the entrance from Castro Valley Boulevard.

The on-site coordinator, with assistance from a trained employee, will implement the use of available absorbent to control the spill and to prevent off-site discharge. All existing floor drains, sumps and storm drains should be covered or diked to prevent the migration of the used oil to the sanitary sewer and/or surface water bodies. The designated Hazardous Material Spill contractor will be notified.

A release which impacts soil and/or groundwater will be cleaned up using one or more of a variety of methods, including, but not limited to, excavation of soil or extraction and treatment of groundwater.

In accordance with State regulations, all spent absorbents and petroleum-impacted soil will be collected in DOT approved containers and then, transported by a licensed hauler to a facility permitted to dispose of hazardous waste.

VI. MONITORING EQUIPMENT MAINTENANCE

The tank monitoring system is tested on a weekly basis by store personnel to assure the alarm is functioning properly.

The tank monitoring system is tested on an annual basis by Precision Environmental, 1081 Alameda De Las Pulgas, #85, Belmont, CA 94002, (408) 992-0603.

The piping is tested on a bi-annual basis by NDE Environmental Corporation, 8906 Wall Street, Suite 306, Austin, Texas 78754, (512) 719-4633.
