Dear Mr. Grayson:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above-referenced site including the recently submitted document entitled, "Work Plan for Delineation of Vertical and Lateral Extent of Contaminant Plume," dated January 14, 2009, which was prepared by Delta Consultants for the subject site. Delta proposes to install seven CPT borings onsite to delineate the vertical and lateral extent of the groundwater contaminant plume. Although, ACEH generally concurs with the proposed scope of work, the work plan as submitted does not adequately address the lateral extent of the contaminant plume and does not address evaluating the integrity of groundwater monitoring well MW1 as previously requested in our October 16, 2008 correspondence. Therefore, ACEH cannot approve the scope of work as proposed and requests that you address the following technical comments and send us the work plan addendum described below.

TECHNICAL COMMENTS

- 1. Soil and Groundwater Characterization As mentioned above, Delta proposes to install CPT borings at seven locations at the site. However, based on concentrations of contaminants detected in groundwater monitoring well MW-5 and the predominant groundwater flow direction depicted on Figure 3 of the above-mentioned work plan, the proposed CPT boring locations do not appear to laterally define the groundwater contaminant plume that may extend off-site towards former groundwater monitoring well MW-9 and Dublin Boulevard. Please justify that the proposed locations adequately define not only the vertical extent of the soil and groundwater contamination, but also the lateral extent, or propose a scope of work to address the above-mentioned concerns and submit a work plan addendum due by the date specified below. Also please include revised site figures that illustrate not only the current site features (i.e. building footprint, locations of UST system and dispensers, etc.) but the former UST system and site features as well.
- 2. Monitoring Well MW1 Evaluation As stated in our October 16, 2008 correspondence, the total depth of groundwater monitoring well MW1 was reported at 9.28 feet below top of casing in the September 19, 2008, "Semi-annual Monitoring Report." However, according to the monitoring well construction details presented in the "Preliminary Groundwater Investigation Report," dated April 7, 1994, the total depth of monitoring well MW1 was reported to be 19 feet. As requested in our October 16, 2008 correspondence, please evaluate groundwater

monitoring well MW1 to ensure that its integrity has not been compromised. Please report your findings in the soil and groundwater investigation work plan addendum due by the date specified below.

3. Alameda County FTP Server & GeoTracker Compliance – A review of the electronic case file indicates that the site is still not in compliance. In order to fulfill your reporting requirements, the electronic copy (PDF) must be uploaded to ACEH's FTP server in addition to the electronic uploads to the SWRCB's GeoTracker website. As of today, the groundwater monitoring reports for 2008 have still not been uploaded to ACEH's FTP server. To regain compliance status, please upload all missing reports to ACEH's FTP website within thirty days from the date of this letter. Electronic reporting is detailed below.

REQUEST FOR INFORMATION

ACEH's case file for the subject site contains the following electronic reports as listed on our website (http://www.acgov.org/aceh/lop/ust.htm). You are requested to submit copies of all other reports related to environmental investigations for this property (including Phase 1 reports) by March 9, 2009.

NOTIFICATION OF FIELDWORK ACTIVITIES

Please schedule and complete the fieldwork activities by the date specified below and provide ACEH with at least three (3) business days notification prior to conducting the fieldwork.

TECHNICAL REPORT REQUEST

Please submit technical reports to ACEH (Attention: Paresh Khatri), according to the following schedule:

- April 6, 2009 Soil and Water Investigation Work Plan Addendum
- April 30, 2009 Semi-annual Monitoring Report (1st Quarter 2009)
- October 30, 2009 Semi-annual Monitoring Report (3rd Quarter 2009)

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used

for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please visit the SWRCB website for more information on these requirements (http://www.swrcb.ca.gov/ust/electronic submittal/report regmissantial.

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety

Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

SUBJECT: Electronic Report Upload (ftp) Instructions

Effective **January 31, 2006**, the Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection. (Please do not submit reports as attachments to electronic mail.)
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- Do not password protect the document. Once indexed and inserted into the correct electronic case file, the
 document will be secured in compliance with the County's current security standards and a password.
 Documents with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

RO#_Report Name_Year-Month-Date (e.g., RO#5555_WorkPlan_2005-06-14)

Additional Recommendations

A separate copy of the tables in the document should be submitted by e-mail to your Caseworker in Excel format.
 These are for use by assigned Caseworker only.

Submission Instructions

- Obtain User Name and Password:
 - a) Contact the Alameda County Environmental Health Department to obtain a User Name and Password to upload files to the ftp site.
 - i) Send an e-mail to dehloptoxic@acgov.org

- b) In the subject line of your request, be sure to include "ftp PASSWORD REQUEST" and in the body of your request, include the Contact Information, Site Addresses, and the Case Numbers (RO# available in Geotracker) you will be posting for.
