This correspondence presents the Alameda County Environmental Health (ACEH) response to the "Case Closure Petition, 76 Station No. 5748/6419, 6401 Dublin Boulevard, Dublin, California, Case No. RO0000459", dated May 21, 2012. The petition was submitted by Pacific Convenience & Fuel and was provided to ACEH in your correspondence dated August 23, 2012.

The petition was submitted to the State Water Resources Control Board on May 21, 2012, 67 days after the date of the "Case Closure Request" dated March 9, 2012, and received by ACEH on March 15, 2012. Prior to the submittal of the petition, ACEH and Antea Group were working cooperatively to move the case to closure. However, due to case worker transitioning at the time of the submittal of the request for closure, ACEH did not respond to Antea Group and Pacific Convenience & Fuel within the 60 day time period allotted by Title 23 of the California Code of Regulations.

Subsequent to the submittal of the request for closure, the state adopted the Low Threat Closure Policy. ACEH has reviewed the case for closure consideration under the new policy and has determined that it meets the General and Media Specific criteria and is prepared to proceed with case closure and begin the public participation process and subsequent well decommissioning.
