10-18-00 Beth Christian with RWQCB called
for an update on whether a workplan
has been submitted for the area near MW-2.
I called and spoke to John Beery and
he said his consultant is working
on the workplan. He said he will
have her contact me. I also advised
Beery to contact Beth Christian to
give her an update on the workplan.

11-30-00 ^(cont)
Spoke to Helen @ 385-4308 the consultant
that is preparing the workplan for the area
around MW-2. She said Beery told her to
put it on hold ~~with~~ while he ~~is~~ negotiating
with the Port of Oakland who should be responsible
since they are taking his land for "free".

Spoke to Robin of Greensfelder & Ass. and she said drilling has been rescheduled for May 9th

4-5-2000

Met with Diane Heinze, Port of Oakland concerning contamination around MW-2. Port of Oakland is involved with the excavation of the shoreline adjacent to 2900 Main St, Ala to increase the diameter of the inner harbor turning basin. There is concern (RWQCB) that contamination may be migrating to the bay since a groundwater sample from MW-2 taken in 8/2000 contained 140,000 $\mu\text{g/l}$ TPH (diesel)

- 2/21/97 Spoke to John Brany, 21-2727, to inquire about the status of the workplan submitted. Mr. Brany said that Tim Tyler was supposed to have submitted w.p. He will contact Tim Tyler & get back to me on the status.
- 3/12/97 Left message for Tim Tyler, (408) 662-8178.

- 10/23/96 Spoke to John Berry. Workplan will be submitted by Nov-18 '96 which will also include work schedule, discussions on why that work adequately addresses any potential threat to surface water. Recommended that consultants submitting bids adequately review former investigation at site & stated that it must be signed off by P.E. or R.G.
- 11/9/96 John Berry called to say that he contracted Environmental Control Associates (ECA) to do work. Tim Tyler is the contact there at 408-662-8178. A workplan will be submitted shortly. Cellular PH: 702-772-8030
- 11/4/96 Left message for Tim Tyler inquiring about submittal of workplan.
- 11/5/96 Tim Tyler, ECA, 916-581-0380, called & discussed workplan. I stated that ultimately our permanent well would have to be placed downgradient of MW-2. He will submit w.p. w/in next two weeks. Workplan will include schedule of work.
- 12/31/96 Left message for Tim Tyler, ECA, regarding the whereabouts of the workplan.
- 12/31/96 Discussed workplan w/ Tim Tyler. The w.p. has not yet been submitted because Mr. Berry has been unable to agree w/ proposals. Will talk to Mr. Berry again. Will also suggest that he apply to Fund.
- 12/31/96 Left message for John Berry re status of w.p. submitted

- 7/18/96 John Berry called back. He will take the County's May '96 letter to Smith Environmental today & try & submit a schedule for the submittal of the required workplan within next week.
