 McGETRICK IN SUPPORT OF  
 ATLANTIC RICHFIELD

16 I, JAMES McGetrick, declare as follows:

17 1. I am employed by ARCO Products Company, a wholly owned  
 18 subsidiary of the Atlantic Richfield Company ("ARCO"), as a  
 19 Manager of Technical Support for QA and Analytical Services. I  
 20 have been employed by ARCO since June 1980; since 1985 I have been  
 21 responsible for product specifications for all of ARCO's petroleum  
 22 products, for all oversight programs involving ARCO products, and  
 23 for quality reports and the registration of gasoline additives  
 24 with the Environmental Protection Agency.

25 2. MTBE was a gasoline additive that could be added to  
 26 gasoline at refineries, although it could also be added at  
 27 terminals. ARCO did not add MTBE to any gasoline in California,  
 28 either at their refineries or terminals, until July 1989 at the

1 earliest.

2 I declare under penalty of perjury under the laws of the  
3 State of California that the foregoing is true and correct and
