Conestoga-Rovers & Associates (CRA) prepared this letter on behalf of Shell Oil Products US dba Equilon Enterprises LLC, as discussed in electronic correspondence between CRA and Alameda County Environmental Health (ACEH), to addend our May 25, 2012 Subsurface Investigation Work Plan (work plan) for the referenced site.

CRA proposes to install four additional nested soil vapor probes (SVP-19 through SVP-21) on site at the locations shown on the attached figure. The probes will be installed and sampled following the procedures detailed in our work plan. Because the underground storage tank excavation was backfilled to 4 feet below grade (fbg) with 1½-inch drain rock and then filled to the surface with compacted road base, it may be necessary to install probe SVP-18 at a depth of 4 fbg with screened intervals at 2 and 4 fbg.

We are tentatively scheduled to begin field work on October 29, 2012.
