Mr. Plunkett: On behalf of Caltrans, Shaw Environmental, Inc. (Shaw) is responding to your letter dated July 24, 2009, regarding Groundwater Monitoring Requirements for the above-referenced site.

Your letter requested that groundwater monitoring be resumed at the site on a semi-annual basis. Please be advised that all groundwater monitoring wells at the site were destroyed sometime in either 1998 or 1999. Our review of the case files indicates that your office was made aware of this fact at least as early as November 1999.

Furthermore, a "Request for Case Closure" dated March 25, 2009, was submitted to you by Shaw on behalf of Caltrans. As of this date, Caltrans has not received a response to the "Request for Case Closure".

We request that you issue a letter rescinding the semi-annual groundwater monitoring requirements for the site, and review and respond to the "Request for Case Closure" at your earliest convenience.
