Please submit all documents relating to environmental assessment or cleanup activities occurring at the site prior to and since May 1991. This collection of documents should also include the report documenting the results of the previous April 1987 UST closures. These documents are due within the next 30 days. Please be advised that this letter constitutes an official request for technical reports pursuant to California Water Code Section 13267(b).
