This office and the San Francisco RWQCB have reviewed the case closure summary for the above referenced site and concur that no further action related to the underground tank release is required at this time. Before a remedial action completion letter is sent, the onsite monitoring wells (MW-1 through MW-3) should be decommissioned, if they will no longer be monitored. Please notify this office upon completion of well destruction so a closure letter can be issued.

Dear Mr. Jensen:

I have completed review of E2's June 1995 Soil and Groundwater Investigation Work Plan for the above referenced site. The proposal to advance three soil borings in the vicinity of the former waste oil excavation to delineate the extent of soil contamination, and to install three groundwater monitoring wells to evaluate water flow direction and quality at the site is acceptable.

The following are recommended changes/additions:

- 1. Soil samples will be collected at 5 foot intervals and at lithologic changes. Soil should also be collected for laboratory analysis if it shows obvious contamination,
- 2. Monitoring wells will be surveyed to the nearest 0.01 foot. It should also be converted to mean sea level, and
- 3. It is proposed to analyze all water samples for TRPH, TPH-G, TPH-D, BTEX, SVOCs, HVOCs, and five metals Cd, Cr, Pb, Ni, and Zn. It is not necessary at this time to analyze water from the upgradient well or from the well downgradient from the former product pit for all the above constituents. Analysis for TPH-G, TPH-D, and BTEX are adequate.

Field work should commence within 60 days of the date of this letter, or by September 5, 1995. Please notify me at least 72 hours prior to the start of field activities.

When three underground storage tanks were removed in May 1994, soil samples collected exhibited up to up to 1,300 ppm TPG-D and 240 ppm TPH-G, 2.7, 3.48, 10 and 12 ppm BTEX, respectively. A groundwater grab sample exhibited up to 6.7 ppm TPH-G and detectable concentrations of BTEX. Following overexcavation, soil collected from the southwest wall exhibited up to 1,300 ppm TPH-D and 280 ppm TPH-G. A fourth UST was removed in October 1994. To date, this office is not in receipt of soil analytical results from this tank removal.

At this time, additional investigations are require to delineate the extent of soil and groundwater contamination resulting from the unauthorized release of fuel products at this site. Such an investigation shall be in the form of a **Preliminary Site**Assessment, or PSA. The information gathered by the PSA will be used to determine an appropriate course of action to remediate the site, if deemed necessary. The PSA must be conducted in accordance with the RWQCB Staff Recommendations for the Initial Evaluation and Investigation of Underground Tanks, and Article 11 of Title 23, California Code of Regulations. The major elements of such an investigation are summarized in the attached Appendix A.


The PSA proposal is due within 45 days of the date of this letter. Once the proposal is approved, field work should commence within 60 days. A report must be submitted within 45 days after the completion of this phase of work at the site. Subsequent reports are to be submitted quarterly until this site qualifies for RWQCB "sign off." All reports and proposals must be submitted under seal of a California Registered Geologist, Certified Engineering Geologist, or Registered Civil Engineer.

#### FINAL NOTICE OF VIOLATION

Underground Storage Tanks located at 3924 Martin Luther Subject: King Way, Oakland, CA 94608

To Whom It May Concern:

Our records Indicate that there are underground storage tanks at the above facility. You were notified of this situation several months ago and have not taken the appropriate action as described below.

In accordance with the California Code of Regulations, Title 23, Chapter 3, Subchapter 16, of the Underground Tank Regulations, you must perform the following actions:

- 1) Submit a tank closure plan to this department as required by Article 7, Section 2670, or,
- Apply for a permit as required by Article 10, Section 2) 2710.

You are directed to notify this department within ten days of your intentions and to obtain the necessary instructions and forms.

Please note that Section 25299 of the California Health and Safety Code states that any operator or owner of an underground storage tank is liable for a civil penalty of not less than five hundred dollars nor more than five thousand dollars per day for failure to obtain a permit, or failing to properly close an underground storage tank, as required by Section 25298.

To Whom it may concern:

During a routine investigation in the area mentioned above, a physical inspection of the above property indicated the possibility of the presence of underground storage tanks(USTs) at the above site. Several photographs were taken of the site from the street showing evidence of what appears at one time to be a gasoline service station.

County Accessors records indicate the Apostolic Church of Deliverance to be the legal owner of the property. If there are USTs at the site it will be necessary to remove them as per State Law. If, however, the tanks have been previously removed, the matter will most likely be closed. If there are no USTs on site please document how and when such removal took place. Please be advised it is in the best interest of the owner of any property that has USTs on site to remove them legally as real estate loans and conveyances of said property are difficult without addressing such matters.

Please contact this office within the next thirty (30) days as to the status of the tanks. This office will help in any way in rendering assistance towards this goal.
