This office has recently reviewed the case file for the above referenced site, to determine whether this site warrants case closure with the Regional Water Quality Control Board.

As documented in the November 21, 1988 Aqua Science Engineers Inc. report, confirmatory soil samples were collected after lateral over-excavation of the UST pit revealed TPHd at concentrations ranging from 800 ppm at the west side to 2300 ppm at the north side. However, benzene concentrations in soil were not reported by Aqua Science Engineers in their September 15 and November 21, 1988 reports for initial UST removal samples and confirmatory over-excavation samples, respectively. In addition, the last groundwater monitoring event occurred on 6/10/91.

Therefore, in order to expedite case closure with the Regional Water Quality Control Board (RWQCB), this office requests that one additional groundwater sampling event be performed for monitoring well MW-1. Sample analytes shall continue to be total petroleum hydrocarbons as diesel and gasoline (TPHd and TPHg) and the aromatic hydrocarbons benzene, toluene, ethyl benzene and total xylene isomers (BTEX).

Please perform this groundwater sampling event no later than July 1997.

If laboratory analysis of the 1st quarter 1997 groundwater sampling documents non-detectable concentrations of TPHd and BTEX, this office will request closure as a "Low-Risk Soils Cases" as defined in the "Supplemental Instructions to State Water Board December 8, 1995, Interim Guidelines on Required Cleanup at Low-Risk Fuel Sites".

This office has recently reviewed the case file for the above referenced site, to determine whether this site warrants case closure with the Regional Water Quality Control Board.

As documented in the November 21, 1988 Aqua Science Engineers Inc. report, confirmatory soil samples were collected after lateral over-excavation of the UST pit. Soil samples collected after over-excavation of the UST pit revealed TPHd at concentrations ranging from 800 ppm at the west side to 2300 ppm at the north side. However, benzene concentrations in soil were not reported by Aqua Science Engineers in their September 15 and November 21, 1988 reports for initial UST removal samples and confirmatory over-excavation samples, respectively. In addition, the last groundwater monitoring event occurred on 6/10/91.

Therefore, in order to expedite case closure with the Regional Water Quality Control Board (RWQCB), this office requests that one additional groundwater sampling event be performed for monitoring well MW-1. Sample analytes shall continue to be total petroleum hydrocarbons as diesel and gasoline (TPHd and TPHg) and the aromatic hydrocarbons benzene, toluene, ethyl benzene and total xylene isomers (BTEX).

Please perform this groundwater sampling event during 1st quarter 1997 (January through March).

If laboratory analysis of the 1st quarter 1997 groundwater sampling documents non-detectable concentrations of TPHd, TPHd and BTEX, this office will request closure as a "Low-Risk Soils Case" as defined in the "Supplemental Instructions to State Water Board December 8, 1995, Interim Guidelines on Required Cleanup at Low-Risk Fuel Sites".

I have been in contact with a Mr. Scott Ferriman of Aqua Science Engineers, and he has been helpful in getting me the information I need to properly complete this site closure summary document. However, Mr. Ferriman informed me that during late 1988 and early 1989 several employees of ASE (who had been associated with this site) left to take employment with ALL Environmental. Dear Mr. Poland:

This letter follows cursory review of the case file for the above referenced site. The case file for this site is incomplete. To the best of my knowledge, the site has one groundwater monitoring well (MW-1) located within 10 feet of the tank pit in the down gradient direction. The initial quarterly groundwater sampling report received by this office is the May 17, 1990 Sampling Specialists report prepared for Aqua Science Engineers. To date, no information documenting additional quarterly groundwater monitoring has been received by our office. In order to properly evaluate this case and expedite eventual case closure with the Regional Water Quality Control Board (RWQCB), this information is needed. Please forward any additional monitoring reports to my attention.

At this time please adhere to a quarterly schedule of well sampling, monitoring, and report submittal as referenced in Title 23, California Code of Regulations (CCR) section 2652(d). Sample analytes shall continue to be total petroleum hydrocarbons as gasoline and diesel (TPHg and TPHd) and the aromatic hydrocarbons benzene, toluene, ethyl benzene and total xylene isomers (BTEX).

Sampling of well MW-1 should continue until four consecutive sampling events have documented acceptable levels of chemicals in groundwater samples collected from well MW-1. After the documentation of four consecutive quarters of groundwater reporting, ACHCSA will re-evaluate the site for possible Regional Water Quality Control Board (RWQCB) case closure. At that time Airborne Express may request site closure from ACHCSA

Please be advised that this letter constitutes a formal request for technical reports pursuant to California Water Code Section 13267(b). Failure to respond or a late response could result in the referral of this case to the RWQCB for enforcement, possibly subjecting the responsible party to civil penalties up to a maximum of \$1,000 per day.

Please respond with this information no later than 30 days from receipt of this letter or November 30, 1995. Additional quarterly groundwater sampling reports should be received by this office no later than 45 days from the groundwater sampling date.


