Dear Mr. Herman:

As you are aware, the oversight for the cleanup at the above referenced site has been transferred to the Local Oversight Program, LOP, a new group working within the Department of Environmental Health, Hazardous Materials Division. This new group will now direct and oversee all remediation of this site and the new contact person is the undersigned Hazardous Materials Specialist.

Upon review of your file, it is clear that upon removal of a 4,000 gallon underground gasoline tank in February 1990, contamination was found in the water sample taken from the excavation pit. soil samples taken were either non-detectable or low enough to reuse as backfill. Ms. Cynthia Chapman of this office then notified you of your need to perform a groundwater investigation. Certified Environmental Consulting, Inc. was contracted to provide a work plan, which consisted of installing three groundwater monitoring wells around the tank pit area. The work plan, although very generic and non-specific, was reviewed and a written approval for this work was given by Ms. Chapman in a November 8, 1990 As outlined in her initial, May 30,1990 letter, your reporting requirements include monthly reports for the first three months after monitoring well installation and quarterly reports thereafter. To this date, some two years later, our office has yet to receive any reports concerning the installation of monitoring wells and the findings of water sampling.

You are directed to submit to our office within thirty (30) days, all technical reports regarding site investigation and remediation on Superior Tiles, 7801 Oakport St., Oakland CA 94621. If no work has been performed, you should submit a work plan with a schedule which outlines the installation of the proposed monitoring wells, along with a scaled map depicting the well locations relative to the former tank pit.

You should consider this a formal request for technical documents pursuant to the California Water Code Section 13267 (b). Any extensions of agreed upon time deadlines must be confirmed in writing by either this Division or the Regional Water Quality Control Board, (RWQCB). Failure to submit the requested documents may subject you to civil liabilities and/or the possible referral of this case to the District Attorney's Office for enforcement.

All reports and technical documents should also be sent to the RWQCB, to the attention of Mr. Rich Hiett. Their address is 2101 Webster St., Fourth Floor, Oakland, CA 94612.
