Title 23 of the California Administrative Code regulates the operation and removal of underground tanks that have contained hazardous materials. It is the Health Agency's role to enforce these standards in the City of Oakland. A review of the plans submitted for removal of the subject tanks reveals that there are several deficiencies. You are required to submit the following:

 A completed Underground Storage Tank Release Form (enclosed). This has to be submitted within five (5) days of notification that a leakage had occurred.

2. A formal closure plan and remediation plan.

3. A deposit of \$450.00 for related review costs. This is not a fixed fee. The current Health Agency's billing rate is \$53.00 per hour.
