It is my understanding that Mr. Paresh Khatri is no longer working on LOP sites and has referred his case correspondence to you until a replacement is made. Therefore, I am sending this you request in his absence.

On September 16, 2010 Atlantic Richfield Corporation (ARC) and Broadbent & Associates, Inc. (BAI) received a *Monitoring Well Destruction and Landowner Notification* letter indicating that the above referenced Site (ACEH RO #2565) is approved for case closure. This letter also requested that a *Well Destruction Report* be submitted to ACEH by December15, 2010. BAI has been working with ARC and BAI subcontractors to complete the well destructions at the Site in a timely manner. However, due to ARC's new safety program and work approval process the initiation of field work has unfortunately been delayed by approximately 8-12 weeks.
