UNDERGROUND STORAGE TANK CLEANUP FUND (FUND), REQUEST FOR FURTHER DOCUMENTATION DURING INITIAL REVIEW: CLAIM NUMBER 018537; FOR SITE ADDRESS: 1758 SABRE ST, HAYWARD

On November 4, 2005, the Fund received and reviewed your recent documentation that was requested on October 3, 2005. However, all of the required documentation was not provided. The following additional information is needed to determine your eligibility for placement on the Priority List:

According to the UST information on the claim application, AC Transit had seven USTs removed and not replaced. The Fund's previous letter requested a copy of all Removal Permits for the USTs that were listed on the claim application. The permits that were provided in your recent submittal of documentation to the Fund did not include the Removal Permits. Please provide copies of the Removal Permits. In addition, include copies of the Upgrade Certificate for the subject USTs.

Claimant was previously requested to provide evidence that the Claimant has complied with the Section 25299.41 of the Health and Safety Code (H&SC). Claimant is again requested to provide documentation that all current and prior UST fees due on or after January 1, 1991 imposed by Section 25299.41 of the H&SC have been paid. If any of the USTs owned or operated had product placed in them on or after January 1, 1991, attach the most recent copy of the UST Fee Return Form filed with the State Board of Equalization (BOE) with proof of payment (copy of canceled check).

In addition, claimant is reminded that claimant does not qualify for the requested Priority Class B nor Priority Class C. Once the Fund determines that the claim is eligible for placement on the Priority List, the claim will be placed in Priority Class D with a deductible of \$10,000.

NOTE: Failure to respond to this request within thirty (30) calendar days from the date of this letter may result in an ineligibility determination of your claim.
