On behalf of Mr. Bruce Burrows of the Burrows Company and Mr. Jim Roessler of Roessler Investments, Inc. (collectively, the "Client"), ERM-West, Inc. (ERM) presents the subject proposed implementation schedule to the Alameda County Environmental Health Care Services Agency, Department of Environmental Health (ACEH). This submittal is presented in partial fulfillment of your Technical Report Request of 18 December 2007, addressed to Mr. Burrows and Mr. Gabriel Chiu of the Gabriel H. Chiu & Lai H. Trust.

As you are aware, ERM has been contracted by the Client to implement the remaining scope associated with the *Vapor Intrusion Investigation Workplan* (Workplan), prepared by AEI Consultants and dated 15 June 2007. It is for this reason that we are providing the proposed implementation schedule for that work. Additionally, ERM is also preparing, and is submitting today under separate cover, the *Workplan for Interim Soil Vapor Remediation*, also pursuant to your Technical Report Request of 18 December.

This proposed schedule takes into consideration your technical comments on the workplan, provided to Mr. Gabriel Chiu in a letter from ACEH dated 25 July 2007. Specifically, it addresses the following:

- Collection and analysis of soil vapor samples;
- Collection and analysis of soil samples;
- Incorporation of findings into an updated Site Conceptual Model (SCM);
- Incorporation of findings (including historical findings) into hydrogeologic cross-sections for purposes of visually displaying and understanding subsurface conditions at the site; and
- Preparation of a report of findings, to include the updated SCM and hydrogeologic cross-sections.

The proposed schedule for Workplan implementation is presented below.

ERM understands that this is an aggressive schedule, and assumes that ACEH will approve this schedule in time for us to implement the field aspects of the project during the week of 4 February 2008. Additionally, we assume that ACEH will be able to provide review comments on the draft report within 2 weeks of receipt. We will continue to coordinate with utility clearance, drilling, and laboratory (both mobile and fixed-base) subcontractors unless otherwise informed by ACEH that this schedule is not realistic.
