Steven,

Per our discussion from last week, we are proceeding with the first phase of drilling work associated with the short term SVE pilot test/longer term IRAP activities at the Dublin Dry Cleaners Site. The field work has been scheduled for the week of June 29 through July 3, 2009.

We will install 11 of the 14 wells included in the approved scope of Work (see attached Figure and per February 2009 Endpoint Work Plan Addendum, 4 March 2009 Alameda County conditional approval of the Work Plan, and 11 March 2009 Endpoint email clarifying the scope of work regarding the two additional wells required by the County). Given their geometry (areal and vertical through mutiple well screen installations at well locations), installation of these wells should be sufficient to assess the efficiency of the SVE remediation system.

The 11 wells to be installed during this first phase are: VE-1S, VE-1D, VE-2S, VE-2D, VE-3S, VE-3D, VM-1S, VM-1D, VM-3S, VM-3D, and VM-4S. We understand that the County may require the installation of he remaining 3 wells, VM-2S, VM-2D, and VM-5D at a later date, depending on the results of the monitoring to be conducted during this first phase of investigation.

We will keep you abreast as the project progresses and the results of the monitoring of the SVE testing become available. To that end, I'm thinking it will be worthhile for us to meet once the results of the short term SVE pilot test are available and before/during the longer term IRAP activities.

> scope reduction to the pilot test/interim remediation activities. He
> was amenable to reduction in scope (i.e., removal of 3 wells from the
> total proposed scope of 14 wells), with the caveat that if monitoring
> of the remainder of the wells do not yield results that address
> remediation objectives, then the County may reserve the right to
> require installation of those three at a later date.
> The above is good news in that it gives us the ability to proceed with
> a reduced scope, with a simple email notification to the County.
> Regarding a kick off meeting prior to initiation of field activities,
> Steven said that he talked to his boss, Donna, and they feel that it
> will be better to meet after we have results from the pilot
> test/interim remediation activities.
> With that in mind, it might be good for us to actually meet after we
> have installed the wells and conducted the short term pilot test. As
> you know, after we have completed the short term pilot test, we are
> planning on running the system for a 2 to 3 month period to acheieve
> significant mass reduction. It might be good for us to push Steven
> and Donna to meet with us prior to/during the 2 to 3 month interim
> remediation period as we should have results of the efficiency of the
> system by then, which help set the stage for developing a road map for
> final site closure (ie., monitoring if the results indicate absence of
> significant mass or limited expansion if measurable mass does remain
> followed by site closure) for the Site.
