Per our conversation this morning, GTI would like to request an extension of the report submittal date for the work plan activities to be conducted at the Springtown Gas site (located at 909 Bluebell Drive in Livermore).

GTI prepared and submitted a work plan for *Additional Site Characterization and Interim Remedial Action*, which was approved (with comments) by Alameda County Environmental Health Services in correspondence dated March 13, 2009. ACEHS directed that a report of findings of the work plan be submitted by July 13, 2009. In correspondence dated June 25, 2009, GTI requested an extension of the report submittal date to October 13, 2009. This extension was approved in your email correspondence of June 29, 2009.

GTI is currently in the planning and permitting process, and expects to have the permitting and drilling completed in October, which would be followed by 4 weeks of injection in November, 2009. We expect to submit a report of findings within 60 days of completing the work plan.
