Alameda County Environmental Health (ACEH) staff has reviewed the fuel leak case file for the above-referenced site and the document entitled, "Soil and Groundwater Investigation Work Plan," dated February 15, 2008 and submitted on your behalf by Stellar Environmental Solutions, Inc (SES). The scope of work in the Work Plan proposes the installation of two soil borings and one groundwater monitoring well. In addition, an interim remediation has been proposed to mitigate residual separate phase hydrocarbon contamination by batch extraction and injection of ORC. ACEH generally agrees with the proposed scope of work as stated in the Work Plan, provided the following technical comments are addressed prior to the implementation of the Work Plan.

We request that you perform the proposed work, and send us the reports described below. Please provide 72-hour advance written notification to this office (e-mail preferred to steven.plunkett@acgov.org) prior to the start of field activities.

TECHNICAL COMMENTS

- Soil Boring Locations. Due to site constraints including overhead and underground utilities and the building foundation it is unclear if contamination of soil and groundwater extends beneath the building. However, the predominantly clay lithology and soil and groundwater data collected from previous investigations suggests that the lateral distribution of petroleum hydrocarbon contamination is restricted to an area adjacent to the former heating oil tank. SES has proposed the installation of two soil borings approximately 200 feet downgradient to evaluate the extent of dissolved phase contamination beneath your site. ACEH has determined that the proposed soil borings are not necessary at this time.
- 2. Interim Remediation. SES proposes to treat contaminated groundwater with an oxygen releasing compound (ORC) to enhance biodegradation and natural attenuation. However, the proposal to inject ORC compound will result in limited distribution of the compound in the subsurface in only the immediate area adjacent to the monitoring well. ACEH recommends the use of multiple injection points rather than monitoring wells -targeting the impacted zone- distributed throughout the source area, resulting in a uniform distribution of the ORC compound.

Also, SES has proposed the installation of one groundwater monitoring well, which will be used for batch extraction of contaminated groundwater.

To evaluate the effectiveness of the remedial action, verification sampling of soil and groundwater will be required. Include your proposal for verification sampling in the report requested below and also present results from the interim remediation in the report requested below.

- **3. Monitoring Well Installation.** ACEH agrees with the proposed monitoring well construction as recommended by SES. Please present results from the monitoring well installation in the report requested below.
- 4. Groundwater Sampling and Analysis. All groundwater samples collected during the well installation are to be analyzed for TPHd by EPA Method 8015M or 8260 and BTEX by EPA Method 8260. In addition, prior to implementation of the remedial action, ACEH requests that groundwater samples should also be evaluated for water quality parameters including methane, dissolved oxygen, oxidation reduction potential and nitrate, sulfate and iron ions. Please present the results from the groundwater sampling in the report requested below.

TECHNICAL REPORT REQUEST

Please submit technical reports to Alameda County Environmental Health (Attention: Mr. Steven Plunkett), according to the following schedule:

September 14, 2008 – Interim Remediation Report

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) Geotracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the Geotracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in Geotracker (in PDF format). Please visit the **SWRCB** website information these requirements for more on (http://www.swrcb.ca.gov/ust/electronic submittal/report rgmts.shtml.

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

SUBJECT: Electronic Report Upload (ftp) Instructions

Effective January 31, 2006, the Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection. (Please do not submit reports as attachments to electronic mail.)
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- Do not password protect the document. Once indexed and inserted into the correct electronic case file, the
 document will be secured in compliance with the County's current security standards and a password.
 Documents with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

RO#_Report Name_Year-Month-Date (e.g., RO#5555_WorkPlan_2005-06-14)

Additional Recommendations

A separate copy of the tables in the document should be submitted by e-mail to your Caseworker in Excel format.
 These are for use by assigned Caseworker only.

Submission Instructions

- 1) Obtain User Name and Password:
