#### Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

For sites which have multiple Responsible Parties, a determination of secondary responsibility may be made based on the following Criteria of Responsibility:

- 1. "The primary Responsible Party is performing corrective action and"
- 2. "It is clear that the party seeking secondary status did not in any way initiate or contribute to the actual discharge."

Required Notification: If the primary Responsible Party fails to perform corrective action, then the secondary Responsible Party or Parties will be considered a primary Responsible Party.

ACEH has named the responsible parties for this site as detailed below.

# Responsible Party Identification

#### Existence of Unauthorized Release

In October 1993 soil bores B-1 to B-4 were installed to assess the site. The soil bores encountered TPH as gasoline concentrations in soil up to 180 milligrams per kilogram (mg/kg), benzene up to 0.23 mg/kg, toluene up to 0.32 mg/kg, ethylbenzene up to 0.56 mg/kg, and total xylenes up to 1.4 mg/kg. In December 1996 bores GP-1 to GP-6 were installed to investigate three dispenser islands and additional, but lower, concentrations of each of these compounds were documented. In September 1997 three gas USTs and one waste oil UST were removed from the site. Confirmation sampling conducted at the time of UST removal documented limited, but additional concentrations of each of the previously listed hydrocarbon compounds. Each sampling event indicates an unauthorized release had occurred.

#### Responsible Party Identification

Diana M. Pagano was the tank owner and property owner at the time of the tank removal. Diana M. Pagano is a responsible party for the site because she owned the underground storage tanks (Definition 1), owned the property where an unauthorized release occurred (Definition 3), and had control of underground storage tanks at the time of or following an unauthorized release (Definition 4). Diana M. Pagano is named as the Primary Responsible Party based on Criteria 1 of Responsibility.

The City of San Leandro purchased the site in March 2010 from Diana Pagano. The City of San Leandro is a responsible party for the site because it owns the property where an unauthorized release occurred (Definition 3). The City of San Leandro is named as a Secondary Responsible Party based on Criteria 2 of Responsibility.
