I spoke with our consultants regarding your concerns over missing information. Below is the response I received. Please let me know if you still require additional information, and/or would like to meet with them.

Thank you for your assistance in this matter.

"I am back in my office and had a chance to review the report "Summary of Work Performed to Date and Additional Site Characterization Results" as well as the "Work Plan Approval for Spills, Leaks, Investigation-Cleanup Case No. R00003010 and Geotracker ID T10000001613, Alameda Federal Building 2C, 620 Central Avenue, Alameda, CA, 94501" from Alameda County Health Care Services.

As far as I can tell all the requests from the county were met. The following is where the requested items are presented in the report:

Technical Comments

- 1. Soil samples were collected from the groundwater interface and changes in lithology and a minimum of every five feet.
- 2. Regional hydrology was reviewed and well screens were set so the well screen intersected the groundwater table.
- 3. A preferential pathway study was performed with a subsurface utility locating company. Depth to the utilities are presented on the graphics in the report, specifically Figures 2 and 3 in the Legend.
- 4. Soil and groundwater from the current investigation are presented on Tables 1 and 2. Historical (only soil was collected) and current data are presented on Figure 2 (Soil) and Figure 3 (groundwater).
- 5. The pipe leak location is shown on Figures 2 and 3.
- 6. Manifests are included as Appendix D.

I can update Table 1 to include the soil results from the initial investigation if that is what Barbara is requesting. I believe all the information required to obtain Site closure is in this report.
