Hi Mark,

This email is a request for an extension for the data packet for the referenced site. Your letter dated 2/24/2015 requested a data packet with recommendations regarding the LNAPL delineation, to be submitted by 4/10/2015.

On March 26, 2015, Trinity Source Group, Inc. (Trinity) conducted the following fieldwork in response to the Alameda County Environmental Health (ACEH) directive letter dated February 24, 2015 at the ABF Freight Facility located at 4575 Tidewater Ave in Oakland, California.

- The 1st Semi-Annual 2015 Groundwater monitoring event was conducted, and groundwater samples were collected and submitted to an analytical laboratory for analysis. The lab results are pending.
- An attempt to video survey the drain/sewer lines inside the maintenance shop was conducted, but due to the poor conditions of the surface drains and cleanouts, the video survey was unsuccessful. The drains inside the building were clogged with debris and/or had standing oily water in them, and the cleanouts outdoors near the maintenance shop were inaccessible without damaging the cleanout vaults. We removed as much of the debris as we could, but not enough to allow the camera to access the sewer lines.

At the request of ABF, Trinity is preparing a cost estimate to contract a plumber to clear out the lines and video survey the system after it is clear.

Based on the conditions we observed, we think it's plausible that the LNAPL is from an indoor spill. We would like to prepare the data packet for submittal after we have a chance to fully evaluate the sewer system cleaning and video. Accordingly, we request an extension to 5/29/2015.
