Thanks for keeping me posted with recent site activities. I'm working my way through emails that accumulated during the week I was out. It looks like there was either a typo or a shortage of allowed spaces in the address field (it's an old data-limited system, but I can be accused of a typo or two in my time as well). I don't believe there will be any problems with the USTCF (UST Cleanup Fund) due to the named RP (Responsible Party) concern, as in the NOR (Notice of Responsibility) Ms. Barger was also named an RP associated with Apex Refrigeration due to the purchase and later dissolution of Apex. I'll update my letter addressee's to include both to document this for future letters (Apex and Pellegrini); I've also updated the address info. The address is already correct on Geotracker and in our data system (but still, thanks for letting me know about the errors).

To keep in good graces with the county (and ultimately the USFCF), once (and presuming this will proceed) you're under contract, please request an extension to the submittal due date with a reasonable explanation and there should be limited reason to deny the request.

Thank you for your email below. Regarding the UST (Underground Storage Tank) cleanup matter, here is some more information for you in order to provide us with a bid to develop a Work Plan for this project. My client does need to respond to the Alameda County Environmental Health (ACEH) dept. as soon as possible, so I would very much appreciate it if you could expedite your reply.

First, the contact at ACEH is Mark Detterman, PE, CEG, and his 4-19-12 email to me is set forth below. Mr. Detterman is "cc" hereto in order to keep him up-to-date on our attempts to retain a contractor and submit the required Work Plan. Note: I have not spoken to Mr. Detterman since April 19th, and have not received any new emails or letters from ACEH.

Second, Mr. Detterman's 3-14-12 "Notice To Comply" letter to my client, Pennie Barger, of Apex Refrigeration, Inc. (d.b.a. "Pelco Sales & Service" or "Pelco Distributors") is attached. Note: ACEH has an incorrect company name for my client. That is, "Pellegrini Refrigeration & Restaurant Equipment Co., Inc." was in business from the 1970's through the 1990's, but that company was purchased, and then dissolved as a corporation, in/around 2003. The owner of the front building, and property, is now "Apex Refrigeration, Inc." Further, ACEH has an incorrect business address for my client. The correct address is "1550 Park Ave., Emeryville, CA 94608", with contact telephone number: (510) 653-9850 and fax number: (510) 653-9854. Also, the company's contact email is: pelco1969@sbcglobal.net. Ms. Barger is our main company contact and is also "cc" hereto.

Third, also attached are documents which I have uploaded from the ACEH County website as per Mr. Detterman's directions in his 4-19-12 email. Note: the assessor's office information therein shows the 2003 transfer of the property from Pellegrini Refrigeration & Restaurant Equipment Co., Inc. (now dissolved) to Apex Refrigeration, Inc.

Fourth, my client had business losses last year, as indicated in their Tax Return, and has very limited resources to complete this UST cleanup project (which, it should be noted, was an underground tank apparently used for heating oil 100 years ago and was long-ago abandoned before my client ever owned the property).
