On behalf of Leslie Mulholland (Fuel Leak Case No. RO0003070), Wheeler Group Environmental LLC in collaboration with EnProbe Environmental Drilling Services are scheduled to conduct drilling and sampling activities at the subject property on Wednesday/Thursday, 1/17/18 & 1/18/18.
