Hi Keith,

We have received a Geotracker rejection notice for Vapor Intrusion Assessment Report that was denied pending submittal of TO-17 EDF & soil pin survey data.

We have recently resampled the vapor points, this time including by TO-17) and intended submit them as directed in a combined quarterly groundwater and soil vapor report. Would you prefer we revise the rejected report to include both rounds of data?

In the Vapor Intrusion Assessment Report, we acknowledged that while ACDEH had requested that one sample be analyzed for naphthalene by test method TO-17, during the ordering of supplies for the 2016Q4 event, the ordering of TO-17 sorbent tubes were inadvertently overlooked and not discovered in time to allow the TO-17 sorbent tubes to be shipped from the laboratory. We also stated in the report that we would ensure that the TO-17 method is implemented in future events.
