Kasey,

To answer your question, it is the policy of Alameda County Environmental Health (ACEH). The two ACEH requirements are the professional stamp and the perjury statement. ACEH requires these to insure that the work was performed in a professional manner and in accordance with current standards of care. Additionally, in the case of the perjury statement, the intent is to obtain a statement that the Responsible Party has not influenced or modified the report content to a degree that changes the professional recommendations identified in a report. If this has not occurred your client should have no problems with signing the perjury statement

Please note that the local oversight agencies need to be informed when investigations encounter contamination. ACEH is the local oversight agency for this case. Hence the document needs to be provided to ACEH in accordance with Attachment 1- Responsible Party(ies) Legal Requirements / Obligations previously provided to you.
