The proposed Boring B-6 can be considered a grab groundwater sample point, located in the basement of the building. This grab groundwater sample point is referenced as Bullet Item #7 on Page 13 of Narrative. Although "B-6" was not referenced, we proposed a boring at this location just in case the water level was lower than the basement slab floor at the time of sampling, and concrete coring and hand auger drilling may be necessary to recover sample.
