This account statement summarizes the activity in the deposit/refund account established for your "Preliminary Site Review" Case overseen by Alameda County Department of Environmental Health (ACDEH) under the Site Cleanup Program (SCP). ACDEH administers the SCP under authority of Health and Safety Code (H&SC) §101480, recovers remedial oversight fees from the Requesting Party (RP) under authority of H&SC §101490, and establishes a deposit/refund account as authorized in Alameda County Ordinance Code § 6.92.040L.

Oversight fees against your account are associated with reports/documents review and "Project kick-off" meeting at our office. Additional oversight fees incurred are related to the requested oversight agency transfer from ACDEH to the Regional Water Quality Control Board.

Our records indicate that your account balance is \$-1,245 (in arrears) at this time. Therefore, in order to close out the remedial oversight case account, we are requesting the submittal of a check made payable to Alameda County Department of Environmental Health in the amount of \$1,245.00.
