Dear Mr. Hill:

This is a notice of an enforcement referral for the subject site. Site Responsible Parties are non-responsive to Alameda County Environmental Health (ACEH) requests and are recalcitrant. The site has accumulated a series of Notice of Violations from ACEH. As a consequence, ACEH is referring this site to the San Francisco Bay Regional Water Quality Control Board for enforcement actions.

## Site Background

Three USTs, a gasoline, a diesel, and a dual-compartment tank (half used for waste oil storage, half used for storage of an unknown liquid) were removed from the site. Visibly stained odiferous soil was noted in the diesel/gasoline UST pit. Soil samples were reported to contain up to 4,800 milligrams per kilogram (mg/kg) total petroleum hydrocarbons as diesel (TPHd) and 1,200 mg/kg total oil and grease (TOG). Concentrations including up to 77,000 micrograms per liter ( $\mu$ g/L) TPHd, 3,200  $\mu$ g/L total petroleum hydrocarbons as gasoline (TPHg), and 240  $\mu$ g/L benzene were reported in groundwater. The lateral and vertical extent of contamination is undefined.

A soil and groundwater investigation (SWI) workplan was approved by ACEH on November 28, 1990. When the SWI Report was not received ACEH sent additional letters requesting SWI Report submittal by April 26, 1992 and May 12, 1997, and October 1999. ACEH requested the Responsible Party comply with Geotracker regulations by August 15, 2008. When the SWI report was not submitted and the site remained unclaimed in Geotracker a Notice to Comply dated January 8, 2009 and a Notice of Violation dated February 25, 2011were issued. There has been no response.

The Underground Storage Tank Cleanup Fund (Cleanup Fund) issued a letter of *Removal of Monies from the LOC*, dated September 5, 1997, stating the funds would be deobligated from the LOC if required documentation wasn't received within 30 days. The Cleanup Fund, in their Second 5-Year Review, dated March 8, 2012, recommended advancing this case to enforcement.
