Per our conversation, we have been contracted by Volvo to complete the tasks outlined in the ACEH letter dated July 14, 2008 and your follow-up letter of March 14, 2012.

In the March 14, 2012 letter, you stipulated the following dates for submittal of technical reports to the ACEH.

April 27, 2012 – Submittal of missing case files.

June 1, 2012 – Site Status Report

PSI has reviewed the case file on line and does not believe that there are any additional reports have been generated. The July 14, 2008 letter also asks that all work completed since 2005 be submitted to the Geotracker website. It is PSI's understanding that no work has been completed at the site since 2005.

For the June 1, 2012 Site Status Report, PSI will be completing the redevelopment, sampling, and groundwater monitoring reporting for the site by the June 1, 2012 deadline. PSI will submit the report and all pertinent data, including a resurvey of the site to the Geotracker website. However, due to the time constraints and level of detail necessary to complete a Site Conceptual Model, we are asking for an extension to July 1, 2012 to complete the SCM.

Per our conversation, we will also give you 24-hour notice for all fieldwork (redevelopment and groundwater sampling).
