Hi Joe.

Good point. Since the wells were sampled once this year and concentrations did not change (non-detectable) and haven't changed since August 2007, please initiate annual sampling in September 2011 for these two wells. The lack of detectable concentrations in MW-12 since 1995, and the largely nondetectable or rare low concentrations in well MW-14 since early 2006 or earlier also indicates the wells can be eliminated in this year's September event. Hope this helps.
