I am willing to accept grab groundwater samples in lieu of monitoring well samples as long as the grab groundwater samples are representative. Therefore, your work plan (due by October 30, 2017) must include the groundwater component in addition to the soil vapor component. Your work plan must also acknowledge that the work will not be reimbursed by the UST Cleanup Fund.
