RE: REQUEST FOR TIME EXTENSION FOR SUBMITTAL OF WORK PLAN
ADDENDUM AND REVISED SOIL EXCAVATION REPORT

Dear Mr. Khatri:

GeoEnviro Services Inc. (GESI) on behalf of Restructure Petroleum Marketing Services (RPMS) is requesting a 30-day time extension for submittal of a soil and groundwater investigation work plan addendum and a revised soil excavation report.

GESI prepared a work plan for additional site assessment dated November 21, 2008 and a Report of Soil Excavation Activities dated November 21, 2008. Upon review of the work plan and the soil excavation report, the County of Alameda Environmental Health Services (ACEHS) issued a letter dated January 9, 2009 requesting the submittal of a work plan addendum and a revised soil excavation report by March 9, 2009.

Work Plan Addendum

The ACEHS letter specifically requested an amendment to the additional site assessment work plan to include additional site assessment in the former source area onsite. In 2008, a new building was constructed above the former source area (located in the northwestern portion of the site). New USTs were installed to the south of the former source area and new fuel dispensers were installed to the southeast of the former source area. GESI understands the need to collect current soil data from the project site in preparation of site remediation. However soil borings in this area may not be feasible. GESI is proposing to conduct a site visit and consultation with the property owner to evaluate potential soil boring locations. GESI has requested a meeting with Mr. Aziz Kandahari (property owner) during the week of March 9, 2009. We will keep you informed of the date and time of the meeting should you consider attending.

Until further evaluation of potential soil boring locations can be conducted, GESI cannot
