Alameda County Environmental Health (ACEH) staff has reviewed the case file including the *Final Remedial Design Implementation Plan* (RDIP) dated December 17, 2014, prepared and submitted on your behalf by URS Corporation (URS). The RDIP was submitted in response to a meeting with you and URS on July 31, 2014. Thank you for submitting the RDIP.

- **January 23, 2014** - Well Destruction Work Plan

- **January 31, 2015** – 4th Quarterly Monitoring and Sampling Report of 2014 (Eight monitoring wells) to be sampled 12/2014
File to be named: RO27_GWM_R_yyyy-mm-dd
- **Sixty Days after completion of Corrective Action Plan:** Excavation and Remediation Report
Files to be named: RO27_EX_R_yyyy-mm-dd
- **Quarterly Groundwater Monitoring and Sampling Reports minimum one year after completion of Corrective Action:** Quarterly Performance Monitoring Reports
Files to be named: RO27_GWM_R_yyyy-mm-dd

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.
