Notice of Intent to Issue a No Further Action Letter

Leaking Underground Storage Tank Sites (Case Nos. 01-3629 and 01-2286) Caltrans Bay Bridge Toll Plaza, O Bay Bridge Toll Plaza, Oakland, Alameda County April 23, 2015

The subject properties are under the regulatory oversight of the San Francisco Bay Regional Water Quality Control Board (Regional Water Board) for the investigation and cleanup of a petroleum release from five former underground storage tank(s) managed as two separate cases as shown on the site map.

Site investigation and cleanup activities have been completed and both of these sites have been evaluated in accordance with the State Water Resources Control Board Low-Threat Policy. The sites appear to meet all of the criteria in the Low-Threat Policy. Therefore Regional Water Board is considering closure of both fuel leak cases.

This notice is being sent to the current landowner in compliance with Health and Safety Code Section 25295.40. It is also being sent to interested parties for this site.

You are hereby advised to contact the caseworker listed below if you have any valid reasons why the case closure should not move forward. The Regional Water Board will consider all comments received by June 23, 2015, and will respond appropriately to any comments received. Please be aware that comments received after this date will not be considered.
