Dear Mr. Plunkett:

On behalf of Caltrans, Shaw Environmental, Inc. (Shaw) has prepared this submittal in response to your letter dated July 3, 2008, regarding the above site. Your letter requested that Caltrans claim the site in the State Water Resource Control Board's GeoTracker system and electronically upload the following information to the GeoTracker system: 1) All analytical data beginning from September 1, 2001 to present, including monitoring well survey data; 2) All reports beginning from July 1, 2005 to present.

Shaw (as an Authorized RP Agent) claimed the site for Caltrans in the GeoTracker system. Caltrans reviewed their projects files for this site and provided all available reports to Shaw for review. In addition, Shaw reviewed all files available electronically through the Alameda County Environmental Health Department (ACEHD) Online Local Oversight Program (LOP) Records. Based on our review, we have found no analytical data or reports for the site were generated within the time frames presented above. Based on our review of available records, our conclusion is there is no further action needed on Caltrans' part in order to comply with the GeoTracker submittal requirements stated in your letter.

Furthermore, in March 2000 the ACEHD indicated their intent to issue a no further action or case closure letter, pending receipt of landowner notification certification (see attachments). Caltrans responded to the ACEHD's request and provided the required notice in a letter dated July 7, 2000 (see attachments). However, there is no record of a no further action or case closure letter being issued by ACEHD, and the GeoTracker system reports site status as "Open – Site Assessment".

On behalf of Caltrans, Shaw is requesting that ACEHD issue a no further action or case closure letter at this time, and update the GeoTracker system status to reflect this case is no longer active.
