Apparently it had been categorized incorrectly.

In regards to an extension, that would be fine. I generally try to make groundwater reports based on previous submittal dates so that it's not a sweat to meet. I'll update Geotracker to reflect this change.

ARCADIS is working on the requests in ACEH's June 30, 2014 Directive however, I wanted to contact you about two items:

1. In ACEH's letter dated June 30, 2014 you state that the Site is out of compliance because the *ACEH Low Threat Closure Policy Checklist and Site Conceptual Model* report, dated July 3, 2013, has not been uploaded to Geotracker.
This report was uploaded to Geotracker when it was submitted to ACEH. Attached is the confirmation sheet from Geotracker that states this report was successfully uploaded on July 3, 2013 at 2:26:59 pm; confirmation number: **7888198137**. Do you want us to re-upload it, or can ACEH locate it in cyberspace?
2. ACEH requests the Semi-Annual groundwater report be submitted on August 1, 2014. Groundwater sampling was conducted at the Site on June 30, 2014 and the analytical results will be available on July 15 according to Test America. Is it possible to get a one week extension and submit this report on August 8, 2014?

Let me know how you want to handle these.
