I do not believe CVS needs to be involved in this meeting as the City of Emeryville has very recently forwarded information to clarify the former location of the Fire Station and it does not appear that CVS has owned the parcel. Apparently, it was my error to include CVS and you in the letter for this particular parcel. I will need to extend an initiation to the "new" owner and probably should delay the meeting for that to occur.

However, please be aware that there is a larger assemblage of parcels for a former development that eventually didn't occur (known as Emery Village Center, with case number RO0002615) that will eventually require CVS / your participation. This assemblage of parcels included the former Fire Station parcel. At this time I would like to limit the meeting to the one specific parcel associated with the former Fire Station. Regardless, thanks for your email and willingness to participate.
