I wanted to check in with you on the status of things at the Greyhound Oakland Site on San Pablo Avenue. Per the most recent ACEH letter, a Feasibility Study and CAP (FS/CAP) for remediation at the Site has been requested with a due date of July 17, 2015. At this time Green Star is working on the FA/CAP but is requesting an extension of 60 days to ensure that all remediation options are property explored to the extent practical and to confer with the client accordingly. This would not affect the semi-annual groundwater event scheduled for August of 2015 with a groundwater monitoring report to follow by October 16, 2015.
