Thanks for taking the time to meet with us two weeks ago. Per the meeting I am attaching the following:

- 1) A Power of Attorney (POA) and a Delegation of Authority (DOA) from BP that grants me signature authority;
- 2) RO0426 (BP 11109) - A letter requesting to do post DPE bail down tests to better understand the nature of SPH;
- 3) RO066 (BP11126) - A letter explaining the use of calcium peroxide will not generate soil vapor and therefore requesting soil vapor monitoring not be required; and
- 4) An excel spreadsheet (copied below) that identifies which sites we would like you to review first.

My notes indicate that you were going to look at the mobile DPE implementation plan for RO014, any chance you have gotten to that yet? It's ranked 2 here because the letter from 11109 is fairly straight forward. However with the recent drizzle we're getting, the soil vapor sites (76 and 14) are taking on some urgency.

I am working on the schedules and hope to have those to you by tomorrow or Monday at the latest. I think that was it but let me know if I owe you something else.

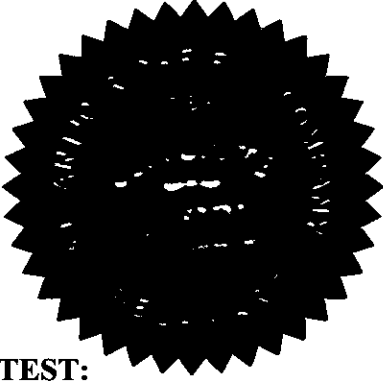
