Re: your request for a meeting. I have recently reassigned this case (& the other 6 related sites) to Steven Plunkett. He has yet to review these cases & will need time to do so. He will be evaluating that the work we have requested to date has been completed and that your current proposals meet regulatory requirements. He will also need to review your current submittal(s) which you have yet to post to the ftp site. Further, please be reminded that implementation of a CAP cannot occur prior to regulatory concurrance and subsequent public comment (public participation). Additionally, SCM development and subsequent investigation & SCM refinement, etc., need to be complete before a CAP can be finalized.

Your e-mails also indicate that you are now considering a more sensitive use for the site (school with minor aged children) than previously presented in the use considerations & technical evaluations presented in your previous technical submittals. This will also need to be considered in identifying/evaluating any proposals for interim cleanup, and final cleanup methods and cleanup levels & goals for the CAP.
